

## SOFTWARE LICENSE AGREEMENT

Thank you for choosing the Dakim® BrainFitness Software (“Software”). This Software License Agreement constitutes the agreement (“Agreement”) between you (“Customer”) and Dakim, Inc., a Delaware corporation having its principle address at 2121 Cloverfield Blvd., Suite 205, Santa Monica, CA 90404 (“Dakim”). Please read this Agreement carefully before using the Software. By using the Software, you agree to be bound by the terms of the Agreement. If you do not accept the terms of the Agreement, promptly return the Software in its original packaging, at your expense, to Dakim for a refund of the purchase price and fees you paid to Dakim.

### 1. Software Description and Requirements

- a. The Software is a computer-based tool that allows individuals licensed to use the Software in accordance with the terms of this Agreement (“Users”) to perform brain fitness exercises to help promote brain health and cognitive fitness.
- b. The Software includes computer programs and code (“Program”), and audio, video, and other media content (“Content”). Purchase of the Software includes an initial one-year subscription to receive Program and Content updates, maintenance, and other support services (“Services”).
- c. The Software provides personalization and automatic adjustment of level of difficulty for up to 10 individual Users based on each User’s profile and past performance. To enjoy the full benefits of the Software, each User must set up a unique user profile by entering his or her name and date of birth and selecting an initial level of challenge.
- d. To receive certain Services, the computer on which the Software is installed must have access to the Internet via a high-speed connection. It is your responsibility to provide Internet access with a minimum download speed of 768k bits per second; Dakim does not provide Internet access, and such access is not included with the Software. Other requirements for the Software to function properly, including minimum operating requirements for the computer on which the Software is installed, are listed in the Software operating manual (“Manual”).
- e. The Software will download and install Program and Content updates automatically in the background while the Software application is open. If a User quits the application before updates are complete, the update process will resume when the application is next opened. As part of the update process, the Software may transmit to Dakim via the Internet certain technical information, such as your Software serial number and the type and version of your computer’s operating system, to facilitate the provision of Services to you. By using the Software, you consent to the transmission of this information to Dakim.
- f. Dakim may — without further notice to you — change, add, update, upgrade, amend or remove features, functionality, and content of the Software and Services.

### 2. License Grant

- a. Subject to the terms of this Agreement, Dakim grants you a limited, non-exclusive license to install the Software on one computer for one User to access and use the

Software for personal, family, or household use within the United States for the limited purpose of performing brain fitness exercises in accordance with the terms of this Agreement (“License”). For purposes of this Agreement, the use by a resident of a senior living community of Software that is licensed to the senior living community shall constitute personal use. Upon payment for the Software, the License becomes perpetual.

- b. Upon payment of the applicable license and Services subscription fees for an additional User (“Additional User License and Subscription Fees”), one additional individual may use the Software under your License. A total of up to 10 different individuals may use the Software under your License.
- c. This License covers and applies to Software updates received during your Services subscription.

### 3. Services Subscription

- a. The initial one-year Services subscription commences upon registration of the Software.
- b. Upon expiration of the initial one-year Services subscription, you will have the option to renew the Services subscription upon the terms and at the prices then in effect. You will not receive Services after expiration of the initial Services subscription unless you renew your Services subscription.

### 4. Installation, Trial Period, and Registration

- a. You may install a copy of the Software on one computer, and try out the Software for a period of ten (10) days from installation of the Software (“Trial Period”) without having to register the Software with Dakim. You will not receive Services, however, until you pay for and register the Software.
- b. To use the Software after expiration of the Trial Period (and to receive Services), you must pay for the Software and register the Software with Dakim. If you do not pay for and register the Software, the Software will not function and your License will terminate upon expiration of the Trial Period.
- c. Upon payment for the Software, Dakim will provide you with a serial number for your Software. After expiration of the Trial Period, the Software will prompt you to enter the serial number in order to continue using the Software.
- d. Provided you have paid for the Software, you may register the Software prior to the expiration of the Trial Period, in which case the Trial Period will terminate and your initial Services subscription will commence with registration. You may also pay for and register the Software after expiration of the Trial Period.

### 5. Money-Back Guarantee

- a. Dakim is committed to your satisfaction as a customer, and offers a 30-day, money-back satisfaction guarantee (“Guarantee”). If for any reason you are not satisfied with the Software, you may return it to the selling retailer within 30 days of the date of purchase for a full refund of the amount you paid. If you purchased directly from Dakim, you may return it to Dakim within 30 days of the date of purchase for a full refund of the amount you paid Dakim, minus any shipping charges listed on your receipt. To qualify for a

refund, returns must include the original box and all the contents including the blue card with the serial number).

- b. To return the Software to Dakim, please call Dakim Customer Service at (888) 693-2546 and request a Return Merchandise Authorization (“RMA”) number. Write the RMA number on your receipt or other proof of purchase, and, within 30 days of the date of purchase, return at your expense the Software DVDs, and any accompanying materials in their original packaging, in like-new condition, along with proof of purchase, to:

- c. You can expect a refund within 30 days of Dakim’s receipt of your return. We will make the refund to you by the same form of payment used in your original purchase.

## 6. Limited Warranty

- a. Dakim warrants to Customer that if you follow the instructions in the Manual, Users will be able to use the Software to perform brain fitness exercises substantially as described in the Manual.
- b. This limited warranty covers the Software for a period of 30 days from registration of the Software.
- c. If during the warranty period a User is unable to use the Software to perform brain fitness exercises as warranted due to a material and reproducible Software failure or malfunction, Dakim will, at its option, either: (i) repair the Software; or (ii) replace the Software. Please see Section 8 of this Agreement for instructions about obtaining warranty service.
- d. If Dakim cannot repair or replace the Software, Dakim will refund the amount you paid Dakim, including shipping charges. You will be required to uninstall the Software, delete any backup copy, and return the Software and associated materials to Dakim to obtain a refund.
- e. This limited warranty does not cover problems caused by: (1) a failure to follow Software operating instructions provided in the Manuals; (2) Internet connectivity issues at the User’s location; (3) accident, misuse, neglect, fire or other external causes; (4) unauthorized use; (5) unauthorized modifications, alterations, or repair of the Software; (6) other acts (or failures to act) by you or others; or (7) events beyond Dakim’s reasonable control.
- f. This limited warranty gives you specific legal rights, and you may also have other rights, which vary from state to state.
- g. This limited warranty is subject to the exclusions and limitations on liability and damages set forth in Sections 7 and 9 of this Agreement.

## 7. Warranty Disclaimers

- a. To the extent permitted by law, the limited warranty and remedies set forth in this Agreement are exclusive and in place of all other warranties and remedies, and DAKIM DISCLAIMS ANY AND ALL OTHER WARRANTIES of any kind, express or implied,

including any implied warranty against interference, infringement, or the like, and any implied warranty of merchantability, fitness for a particular purpose, accuracy or non-infringement of third-party rights. To the extent permitted by law, any such statutory or implied warranties that cannot lawfully be disclaimed shall be limited in duration to the duration of the express limited warranty set forth in Section 6 of this Agreement, and the remedy for breach of any such statutory or implied warranty shall be limited to repair or replacement of the Software, as determined by Dakim in its sole discretion. Some states do not allow exclusion of implied warranties or limitations on how long an implied warranty lasts, so the above limitations may not apply to you.

- b. Dakim does not warrant, represent, or promise that the Software will meet your or a User's specific requirements, that the use of the Software will be uninterrupted, timely, secure, or error-free, or that Dakim will provide Program or Content updates or upgrades at any particular time or on any specific schedule.
- c. Dakim makes no warranty, representation or promise:
  - i. as to the accuracy or reliability of any information presented in the Content, whether that Content is proprietary to Dakim or a third party; or
  - ii. that the Software, Services, and complimentary headset (if any) will be compatible with any other particular equipment, hardware, software or service.
- d. Nothing in the Manual constitutes a promise, warranty, or obligation of Dakim.

#### 8. Instructions for Warranty Service

- a. To obtain warranty service, please contact Dakim Customer Service by calling Dakim's toll free number at 800-853-7289, by sending an email to [support@dakim.com](mailto:support@dakim.com), or by writing to Dakim at 2121 Cloverfield Blvd., Suite 205, Santa Monica, CA 90404.
- b. You must allow Dakim representatives reasonable access to the Software through the Internet to perform diagnostics and, if needed, to provide repairs. If Dakim determines that the Software cannot be repaired remotely through electronic transmission, you will need to return the Software to Dakim, at your expense, to an address specified by Dakim. You should deliver the Software DVDs to Dakim in either the original packaging or in equally protective packaging.

#### 9. Limitations on Liability and Damages

- a. In no event will Dakim be liable to Customer or a User for any indirect, consequential, special, or incidental damages arising from or relating to this Agreement, or for any use of the Software. Some states do not allow the exclusion or limitation of incidental or consequential damages, so this limitation/exclusion may not apply.
- b. Dakim's total cumulative liability under and relating to this Agreement will not exceed the aggregate amount Customer pays to Dakim for the Software and Services.

#### 10. Scope of License

- a. The Content is to be accessed and used only with and through the Software.
- b. You may not, and may not permit others, to:

- i. decompile, disassemble, distribute, tamper with, provide unauthorized access to, sell, rent, lease, exchange, transfer ownership of, sublicense, broadcast, publish, publicly display, modify, create a derivative work based upon, or reverse engineer the Software;
  - ii. reproduce, prepare derivative works of, distribute, perform, or publicly display Content or other material copyrighted by Dakim or a third party without the prior written permission of the copyright holder; or,
  - iii. use or access the Software other than for personal, family, or household use.
- c. You may make one backup copy of the Software DVDs. You may use the backup copy only to reinstall the Software on the computer on which the Software is registered. You may not otherwise copy the Software except as expressly authorized by law or this Agreement.
- d. Violation or breach of any restriction, limitation, or other provision of this Agreement automatically terminates your License and all rights thereby granted to you. Upon termination of your License for violation or breach of this Agreement, Dakim shall have the right to exercise any and all remedies to which it may be entitled, including electronic self-help such as remote disabling of the Software.
- e. Ownership of and title to any medium in which Software is delivered to you passes to you upon your payment of the purchase price and the delivery of the medium to you.
- f. Third parties whose software or content is made available to you as part of the Software or Services retain title to and ownership of the respective software, content, copyrights, trademarks, and other intellectual property rights.
- g. The Software includes third parties' software — including Open Source Software — that Dakim has permission to use, modify, copy, and distribute. Many of those third-party licensors impose certain restrictions or requirements on use of their software and require or request that certain notices or disclosures be given to end-users and Dakim's licensees. Please refer to Appendix A to this Agreement for further details about third-party software.

## 11. Transfer of Software

- a. You may transfer the Software to, and register it for use on, another computer. To do so, you must deactivate the earlier installation and, once the Software is installed on the new computer, re-register the Software with Dakim. Services will continue upon re-registration for the remainder of your existing Services subscription term.
- b. You may not sell the Software to a third-party. You may, however, transfer the Software, any unexpired Services subscription, and associated License to an individual person, provided that:
  - i. you do not charge for the transfer;
  - ii. the person to whom you transfer the Software agrees to and accepts the terms of this Agreement as a condition of the transfer;
  - iii. you uninstall the Software from your computer and destroy any backup copy; and

- iv. you deactivate your registered installation.
- c. You may allow another person to use your Software DVDs to install the Software on another computer without transferring the License to such person or deactivating your registration. The person who installs the Software with your DVDs will be able to try the Software for free for a Trial Period as provided in Section 4 of this Agreement but must pay for and register the Software with Dakim upon expiration of the Trial Period in order to continue using the Software and to receive Services.
- d. You must uninstall the Software and deactivate your registered installation prior to transferring, abandoning, or otherwise disposing of the computer on which the Software is installed.
- e. To deactivate the registered installation of the Software or to re-register the Software upon transfer, please contact Dakim Customer Service at (888) 693-2546 for instructions on how to do so.

## 12. Payment

- a. Dakim may accept as payment an approved credit or debit card.
- b. You must pay the purchase price for the Software, which includes an initial one-year Services subscription, before you can register the Software with Dakim.
- c. You must pay the applicable Additional User License and Subscription Fees in effect at the time you add Users before additional Users are licensed to use the Software. The Additional User Subscription Fee(s) will be prorated based on the proportion of your Services subscription term remaining at the time you add additional User(s).
- d. To continue to receive Services after expiration of your Services subscription term, you must pay to renew your subscription upon the terms and at the prices then in effect.
- e. If required by law, Dakim will charge you sales tax in addition to the purchase price based on your shipping address and the sales tax rate in effect for the state to which your order is being shipped at the time your order is billed.

## 13. Confidentiality and Use of Information

- a. Dakim may incorporate any suggestions that you or a User may make to Dakim into the Software or any commercial product without compensation to you. It is acknowledged and agreed by the parties that you do not have any property rights or proprietary claim to those suggestions.
- b. Subject to your prior approval, Dakim has the right to use your name, address, testimonial, comments, opinions, or other similar information for marketing and advertising purposes.
- c. Dakim respects your privacy and will keep personal information confidential, and will ensure its employees, contractors, and agents keep such information confidential. You acknowledge and agree, however, that Dakim may collect raw data generated by Software usage and may use such data in any way that does not reveal confidential or personal information to third parties.

#### 14. Miscellaneous Provisions

- a. Export Restrictions. The Software is subject to United States export laws and regulations. You must comply with all domestic and international export laws and regulations that apply to the Software. These laws include restrictions on destinations, end users and end use.
- b. Choice of Venue and Law. The parties acknowledge and agree that this Agreement is being formed, and will be substantially performed, in Los Angeles County, California. Any legal action related to this Agreement shall be governed, construed, and enforced in accordance with the laws of the State of California, and venue shall be exclusively in Los Angeles County, California.
- c. Merger Clause. There are no oral or written representations, understandings, or agreements that are not fully expressed in this Agreement. Only a written instrument duly executed by you and Dakim may amend this Agreement.
- d. Severability. If a Court or other competent tribunal declares any provision of this Agreement invalid, all other provisions not declared invalid shall remain in effect.
- e. Succession and Assignment. The terms of this Agreement shall apply to and shall be binding upon a party's successors in interest. You may not sell, assign, or otherwise transfer your rights, benefits, and obligations under this Agreement except as expressly authorized in this Agreement without Dakim's prior written consent, and any attempt by you to do so shall be null and void. You agree that Dakim may sell, assign, or transfer its rights, benefits, or obligations under this Agreement without your consent.
- f. Force Majeure. No delay, failure, or omission on the part of Dakim to perform, or observe any of the terms and conditions of this Agreement shall give rise to any claim against or be deemed a breach of this Agreement if such delay, failure, or omission arises in whole from any cause or causes that are beyond Dakim's control — whether such events exist on the date of this Agreement or arise thereafter — including, without limitation: fires, explosions, or other similar property casualties; adverse meteorological or geological conditions; acts of God; strikes, lockouts, boycotts, or other labor or industrial strife; acts of war; insurrections, riots, or other civil disturbances; epidemics; and, delays or failures of carriers.
- g. Future Transactions. Dakim reserves the right to change the terms and conditions applicable to any future transaction or agreement between you and Dakim.
